Rehabilitation of Sewer Pump Stations V1-02, V1-03, V1-04, V1-06, V1-07, V1-08, V1-09, V1-10, & V1-11

To be a valid delivery, Sealed Bids **must** be delivered by hand to St. Bernard Parish Government, Department of Public Works, 8201 West Judge Perez Drive, Room 240, 2nd Floor, Chalmette, Louisiana during normal business hours of 8:30 a.m. to 4:30 p.m. Monday through Friday on or before 2:00 p.m., Tuesday, April 1, 2008.

Sealed bids delivered to any other St. Bernard Parish Government location or other room number prior to the bid receipt deadline will not be considered.

This project consists of furnishing all labor, equipment, and materials necessary to rehabilitate sewer pump stations at various locations throughout St. Bernard Parish as depicted in the Contract Documents which further define the Scope of Work.

A mandatory pre-bid conference will be held on March 20th, 2008 at 10:30 AM local time at the offices of the St. Bernard Parish Water & Sewer Division, 1111 East St. Bernard Highway, Chalmette, LA 70044.

Each bid must be accompanied by a certified check, cashier's check or bid bond acceptable to the Owner in the amount equal to at least five percent (5%) of the total amount bid and payable without condition to the Owner as a guarantee that the bidder, if awarded the contract, will promptly execute a contract in accordance with his proposal and all terms and conditions of the Contract Documents.
